### **On an authorisation of the biocidal product SOJET**

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Sharda Cropchem España S.L.** on 8<sup>th</sup> April 2020 concerning an authorisation of **SOJET** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics developed by the reference Member States – Germany.

Therefore, in accordance with Article 33 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation (EU) No 528/2012), LEGMC authorises **SOJET** on the basis of mutual recognition process.

**SOJET** contains **10%** of *imidacloprid* (CAS No. 138261-41-3, EC No. 428-040-8) and **0.1%** of *cis-tricos-9-ene (Muscalure)* (CAS No. 27519-02-4, EC No. 248-505-7) as active substances.

LEGMC assigns the authorisation number **LV/2020/MR/009**.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation is valid until **13<sup>th</sup> December 2023**.

Additional trade names:

- *PROFI FLY BAIT*,
- *FLYKILL 10 WG*.

The authorisation holder is **Sharda Cropchem España S.L.**

The authorisation is granted on the following terms:

- Product type: 18 – insecticide;
- Target organism: flies (Muscidae);
- Users: professional;
- Product description: water-dispersable granules;
- Product stability: 12 months;
- Field of use – indoor use, painting on cardboards

- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product SOJET in the composition, form and packing for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) should be as it is indicated in the first authorisation of the above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012;*
- *Regulation (EC) No 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

Sharda Cropchem España S.L. shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of SOJET through mutual recognition may be re-opened for review before 13<sup>th</sup> December 2023.

Application on renewal of an authorisation shall be submitted according to *Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.*

Additionally, LEGMC would like to inform that Sharda Cropchem España S.L. is fully responsible of the content of the biocidal product SOJET as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Sharda Cropchem España S.L. to notify the above mentioned information down to supply chain.
