## On an authorisation of the same biocidal product KILRAT RODENTICIDE FRESH BAIT

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Bábolna Bioenvironmental Centre Ltd.** on 7<sup>th</sup> August 2018 concerning an authorisation of **KILRAT RODENTICIDE FRESH BAIT** according to *Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013).* 

The reference product is *ACTIPASTA-BROD* (authorisation number - LV/2018/MR/021) authorised through mutual recognition in Latvia 16<sup>th</sup> October, 2018. Authorisation holder is **Activa s.r.l.**, Via Feltre, 32, 20132 Milano, Italy.

Bábolna Bioenvironmental Centre Ltd. submitted application for authorisation of a same biocidal product KILRAT RODENTICIDE FRESH BAIT according to Article 2 of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between KILRAT RODENTICIDE FRESH BAIT and ACTIPASTA-BROD that is the subject on an administrative changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013).

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product the KILRAT RODENTICIDE FRESH BAIT.

**KILRAT RODENTICIDE FRESH BAIT** contains **0.0025** % (w/w) of brodifacum (CAS No. 56073-10-0; EC No. 259-980-5) as active substance.

LEGMC assigns the authorisation number for same biocidal product KILRAT RODENTICIDE FRESH BAIT:

The authorisation of KILRAT RODENTICIDE FRESH BAIT is valid until 31st December 2022.

The authorisation number of KILRAT RODENTICIDE FRESH BAIT shall be indicated on the label of the biocidal product.



The authorisation of KILRAT RODENTICIDE FRESH BAIT is granted on the following terms:

- Product type: 14 Rodenticides.
- Target organism House mice (Mus musculus) and brown rat (Rattus norvegicus):
- Users: professional and general public;
- Product description: Paste bait ready-to-use:
- Product stability: shelf life 2 years;
- Use area: indoor, outdoor around buildings;

The authorisation applies only to the same product KILRAT RODENTICIDE FRESH BAIT in the form and composition, form and packing according to the reference product ACTIPASTA-BROD for which the first authorisation is granted by reference Member State – Italy.

The information on the label (and if applicable an enclosed instruction of use) of the KILRAT RODENTICIDE FRESH BAIT should be as it is indicated in the first authorisation for ACTIPASTA-BROD, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for dame product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

Bábolna Bioenvironmental Centre Ltd. as the authorisation holder shall inform LEGMC about any changes in accordance with Regulation (EU) No 354/2013.

Additionally LEGMC would like to inform that Bábolna Bioenvironmental Centre Ltd. is fully responsible of the content of the biocidal product KILRAT RODENTICIDE FRESH BAIT as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Bábolna Bioenvironmental Centre Ltd. to notify the above mentioned information down to supply chain.
