On an authorisation of the same biocidal product Biocidal hlora

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **PCC Rokita SA** on 27th December 2022 concerning an authorisation of **Biocidal hlora** according to *Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013)*.

The reference product is **Arche Chlorine** (authorisation number – **EU-0026816-0000**) authorised with *Commission Implementing Regulation (EU) 2023/754 granting a Union authorisation for the single biocidal product ‘Arche Chlorine’ in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) 2023/754)*. Authorisation holder for Union authorisation is **ARCHE Consortia**, Address - Liefkensstraat 35D, 9032 Wondelgem, Belgium.

PCC Rokita SA submitted application for authorisation of a same biocidal product **Biocidal hlora** according to Article 2 and 3(1a) of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between **Biocidal hlora** and **Arche Chlorine**:

- trade name;
- authorisation holder.

The above mentioned differences are the subject of an administrative changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013)*.

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product the **Biocidal hlora**.

The biocidal product **Biocidal hlora** contains **100.0 % (w/w)** of active chlorine released from chlorine (CAS No. -; EC No. -) as active substance.

LEGMC assigns the authorisation number for same biocidal product Biocidal hlora:

LV/2023/SB/006

The authorisation of Biocidal hlora is valid until 30th April 2033.

The authorisation number of **Biocidal hlor** shall be indicated on the label of the biocidal product.

The authorisation of **Biocidal hlor** is granted on the following terms:

- Product type: 2 – Disinfectants and algaecides not intended for direct application to humans or animals; 5 – Drinking water;
- Target organisms: bacteria (including *legionella pneumophila*) and viruses;
- Users: Industrial and professional;
- Product description: Gas.

The authorisation applies only to the same product **Biocidal hlor** in the form and composition, form and packing according to the reference product **Arche Chlorine** for which the Union authorisation is granted by *Regulation (EU) 2023/754*.

The information on the label (and if applicable an enclosed instruction of use) of the **Biocidal hlor** should be as it is indicated in the first authorisation for **Arche Chlorine**, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for same product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

PCC Rokita SA as the authorisation holder shall inform LEGMC about any changes in accordance with *Regulation (EU) No 354/2013*.

Additionally, LEGMC would like to inform that **PCC Rokita SA** is fully responsible of the content of the biocidal product **Biocidal hlor** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask **PCC Rokita SA** to notify the above mentioned information down to supply chain.
