Acceptance of notification of administrative change – Aqua Primer 2907-02 (NO-2014-0072)

We refer to your notification for an administrative change to the biocidal product family authorisation for *Aqua Primer 2907-02 – NO-2014-0072*. – Case no. BC-ND024467-45

According to Article 50 (2) in Regulation (EU) No 528/2012 concerning the making available on the market and use of biocidal products, changes to the conditions laid down in a biocidal product authorisation shall be accepted/approved by the Competent Authority. Changes to a product authorisation are further described in Regulation (EU) No 354/2013.

We hereby confirm that we accept the notification for administrative changes to *Aqua Primer 2907-02*.

The notification concerns

- Addition of a formulator (Teknos factory in Rajamäki) of the biocidal product, where the biocidal product composition and the formulating process remain unchanged
- Change in the name or the administrative details of a manufacturer (ISP Horhausen GmbH is now owned by TROY CHEMICAL COMPANY BV) of the active substance, where the manufacturing location and process remain unchanged and the manufacturer remains listed in accordance with Article 95(2) of Regulation (EU) No 528/2012
- Deletion of a manufacturer or a manufacturing location of the active substance IPBC – (Dow Benelux BV, R2 Group A/S and Lanxess Deutschland GmbH has been removed from the SPC)
- Change of the classification and labelling to comply with Regulation (EC) No 1272/2008,

as referred to in Section 1 of Title 1 to the Annex to Regulation (EU) No 354/2013.

No other changes than the above mentioned is accepted with this letter.

The product family includes the following products; Aqua Primer 2907-02 Colourless (reference product, NO-2014-0072-01), Aqua Primer 2907-02 Spruce 9002 (NO-2014-0072-02), Aqua Primer 2907-02 Palisander 9016 (NO-2014-0072-03).

The revised SPC is uploaded in R4BP3. In some cases a PDF-format of the SPC is automatically generated in R4BP3. In such cases, please refer to the uploaded SPC in xml-format, as the automatically generated pdf-format seem generally to contain some mistakes.
