

Transfers within the 2023 budget since last notification

In line with Article 26(1) of ECHA's Financial Regulation, the budget transfers carried out (until 20 November 2023) under the responsibility of the Executive Director since the last notification to the Management Board are listed hereunder:

a) 9 October 2023: Transfer within ENV Title 5 – Operational expenditure

With regard to a Persistent Organic Pollutants (POPs) proposal and the consequent stakeholder consultation, ECHA engaged, via a very low value contract, an external expert to address the numerous comments, some of which were of a highly specific nature, to meet the proposal's timeline. Such an activity was not anticipated in the budget and, therefore, a transfer between budget lines within Title 5 (as per the table below) was required.

e) 7 November 2023: Transfer within REACH Title 3 – Operating expenditure

Following a review of the Title 3 budget, and taking into consideration that the previous revision took place in July 2023, some of the available amounts needed to be re-allocated to budget lines that were short of appropriations.

The amounts budgeted for Substance evaluation and Rapporteurs (Multiannual budget line 3111) are provisional and there was a higher than anticipated budget need of payment appropriations to cover the payments related to the number of Applications for Authorisations and restriction dossiers agreed in Committees in the trimester of the year. In addition, the small surplus in the commitment appropriations on this line was needed to support an additional component to a QSAR contract on budget line 3801 (Cooperation with international organisations for IT program – Multiannual).

Furthermore, the actual need for certain communication activities on budget line 3013 was lower than anticipated while, in parallel, there was a higher need on the Management Board budget line 3022 to support the organisation of a Chemical Authorities meeting.

Therefore, a transfer between budget lines within Title 3 (as per the table below) was required.

To date, there were higher than anticipated needs for recruitment and resettlement allowances, and replacements by external staff (interims) and, in parallel, there were funds available on the 'Temporary agents' budget line. In addition, a small increase was needed on the budget line for Medical services and social welfare of staff and, at the same time, there was a surplus on the budget line for further training and language courses for staff. Therefore, a transfer between budget lines within Title 1 (as per the table below) was required.
