On administrative changes – merge of product authorisation in a family ALPHACHLORALOSE GRAIN

Latvian Environment, Geology and Meteorology Centre (LEGMC) on 9th July 2019 received the application submitted by LODI S.A.S. on a merge of biocidal product **BLACK PEARL GRAIN** authorisation in a family **ALPHACHLORALOSE GRAIN** according to Article 6 of *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013)*.

The authorisation for the biocidal product **BLACK PEARL GRAIN** was granted on 27th November 2015 in accordance with Article 33 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012)* on the basis of mutual recognition of a national authorisation issued by reference Member state – France.

On 26th March 2018 reference Member state approved the application on a merge of the above mentioned product in a biocidal product family **ALPHACHLORALOSE GRAIN**.

LEGMC has agreed with developed Product Assessment Report and Summary of Product Characteristics for biocidal product family **ALPHACHLORALOSE GRAIN**.

Therefore, LEGMC agrees to merge the authorisation of the **BLACK PEARL GRAIN** in a family **ALPHACHLORALOSE GRAIN** by following the conditions of the mutual recognition process.

The biocidal product family **ALPHACHLORALOSE GRAIN** contains active substance *alphachloralose* (CAS No 15879-93-3, EC No 240-016-7), concentration range 4-4%.

LEGMC assigns the authorisation number for biocidal product family **ALPHACHLORALOSE GRAIN**:

The authorisation holder in Latvia is **LODI S.A.S.**

The authorisation is valid until 30th June 2021 based on reference Member State decision.

The following members and trade names are authorised within family:

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation is granted on the following terms:

- Product type: 14 – Rodenticide;
- Target harmful organisms: house mouse - *Mus Musculus*;
- Users: professional and non-professional;
- Product description: granular bait;
- Product stability: 2 years from manufacturing date;
- Use area: indoors;
- Packaging size and material: packaging sizes and materials for professional and non-professional users are indicated in Summary of Product Characteristics.

The authorisation applies only to the biocidal product family **ALPHACHLORALOSE GRAIN** in the composition, form and packing for which the first authorisation was granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the biocidal product family **ALPHACHLORALOSE GRAIN** should be as it is indicated in the first authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012;
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

LODI S.A.S. shall inform LEGMC about any changes in accordance with Regulation (EU) No 354/2013.

If the authorisation issued by reference Member State is amended or revoked, the authorisation of the **ALPHACHLORALOSE GRAIN** may be re-opened for review before 30th June 2021.

Additionally LEGMC would like to inform that LODI S.A.S. is fully responsible of the content of the biocidal products included in biocidal product family **ALPHACHLORALOSE GRAIN**, as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask LODI S.A.S. to notify the above mentioned information down to supply chain.
