On the authorisation of the biocidal product family *Lignofix P* through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by STACHEMA CZ s.r.o. on 16th March 2015 concerning an authorisation of the biocidal product family *Lignofix P* through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for biocidal product family *Lignofix P* developed by the reference Member State – Czech Republic.

Therefore, in accordance with *Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (Regulation 528/2012), LEGMC authorises the biocidal product family *Lignofix P* on the basis of mutual recognition process.

The authorisation holder for the biocidal product family *Lignofix P* in Latvia is:

STACHEMA CZ s.r.o.

The biocidal product family *Lignofix P* contains the following active substances:

- *boric acid* (CAS No.10043-35-3, EC No.233-139-2), concentration range **1.8 - 18%**;
- *alkyl (C12-16) dimethylbenzyl ammonium chloride (ADBAC/BKC (C12-16))* (CAS No.68424-85-1, EC No.270-325-2), concentration range **1.8 - 18%**.

LEGMC assigns the authorisation number for biocidal product family *Lignofix P* through mutual recognition:

LV/2018/MR/005

The authorisation of biocidal product family *Lignofix P* is valid until 3rd November 2022 based on reference Member State decision.

In accordance with Article 22(2)(d) of the Regulation (EU) 528/2012 authorisation numbers with the following suffix for biocidal products within family *Lignofix P* are indicated in the following table:

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of the biocidal product family *Lignofix P* is granted on the following terms:

- Product type: 8 – Wood preservative;
- Fields of use: Use Class 1, Use class 2 (for softwood);
- Target organisms: Wood rotting fungi (hyphae), wood boring beetles (larvae), mould fungi (hyphae);
- Users: Industrial and professional (only for *Lignofix P bezkrāsains*, *Lignofix P brūns* and *Lignofix P zaļš*), non-professional (only for *Lignofix Profi bezkrāsains*, *Lignofix Profi brūns*, *Lignofix Profi zaļš*, *Lignofix E-Prevent bezkrāsains*, *Lignofix E-Prevent brūns*, *Lignofix E-Prevent zaļš*);
- Product stability: up to 2 years;

The authorisation applies only to the biocidal product family *Lignofix P* in the composition, form and packing for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the biocidal product family *Lignofix P* should be as it is indicated in the first authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012;
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;*
- all other relevant legislation shall be applied.

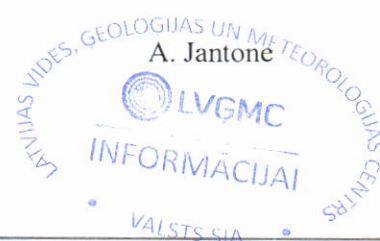
STACHEMA CZ s.r.o. shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of the biocidal product family *Lignofix P* may be re-opened for review before 3rd November 2022.

Additionally LEGMC would like to inform that STACHEMA CZ s.r.o. is fully responsible of the content of the biocidal products included in biocidal product family *Lignofix P*, as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask STACHEMA CZ s.r.o. to notify the above mentioned information down to supply chain.
