#### **5.1. Instructions for use**

- Comply with the instructions for use.
- To achieve the best attraction effect, it is recommended to use 3 traps, each 5 m apart around the relevant area.
- Hang or place the trap, ideally in a warm, sunny place.
- Product is efficient until 8 weeks.
- Level of water within the trap needs to be checked regularly to maintain efficacy of the product. Make sure that the trap does not dry out.
- Once the trap is full of dead flies, the trap can be removed or replaced if needed.

- IF ON SKIN: Wash skin with water. If symptoms occur call a POISON CENTRE or a doctor.
