## Acceptance of administrative change to the authorisation for DP Multipurpose Products (Ireland) Limited – Doff 2 i 1 Maurlokkeboks NO-2021-0211

With reference to the notification dated 11.07.2023 for administrative changes to the authorisation of the biocidal product Doff 2 i 1 Maurlokkeboks, R4BP 3 case number BC-KW087585-95.

### Decision

The Norwegian Environment Agency hereby accepts the notified administrative changes to the product authorisation for Doff 2 i 1 Maurlokkeboks on the Norwegian market.

### Terms and conditions for the change to the authorisation

The revised terms and conditions are described in the final Norwegian Summary Product Characteristic (SPC) attached to the R4BP3 asset case no. NO-0026920-0000. The final SPC can also be found on the website of the European Chemicals Agency here: [Information on biocides - ECHA \(europa.eu\)](#). The terms and conditions as stated in the authorisation letter dated 11.08.2021 also apply.

The approval is given in accordance with Article 6(4) of Regulation (EU) No 354/2013, c.f. Article 50 of Regulation (EU) No 528/2012 (the Biocidal Products Regulation, BPR).

## Background

Regulation (EU) No. 528/2012 and Regulation (EU) No 354/2013 are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No. 480.

The procedure for applications for administrative notifications to authorisations are set out in Article 6 of Regulation (EU) No 354/2013.

### **The notification concerns**

DP Multipurpose Products (Ireland) Limited has notified administrative changes to the authorisation of Doff 2 i 1 Maurlokkeboks on the Norwegian market. The notified changes concerns change of business name and address of Smartec, the owner of the reference product, to SmarTec Solutions Sarl. 13 Chemin des Tresans, 1295 Mies, Switzerland, info@ smartec-Solutions.ch, as referred to in Section 1 of Title 2 to the Annex to Regulation (EU) No 354/2013. In addition, a new manufacturing site, Endeks in Istanbul, is added, as referred to in Section 2 of Title 2 of the same regulation.

## Evaluation by the Norwegian Environment Agency

The Norwegian Environment Agency considers the changes to meet the conditions in Title 1, Section 1 and 2 of Annex to Regulation (EU) no 354/2013 and therefore are acceptable.
