On an authorisation of the biocidal product non flammable aircraft insecticide phenothrin

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Produits Sanitaires Aéronefs** on 17 January 2020 concerning an authorisation of **non flammable aircraft insecticide phenothrin** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **non flammable aircraft insecticide phenothrin** developed by the former reference Member States – United Kingdom (National autorisation: UK-0013475-0000) and amended by new reference Member State – France (National autorisation: FR-0013341-0000).

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises the non flammable aircraft insecticide phenothrin on the basis of mutual recognition process.

The authorisation holder for **non flammable aircraft insecticide phenothrin** in Latvia is:

Produits Sanitaires Aéronefs

The biocidal product **non flammable aircraft insecticide phenothrin** contains active substances *1R-trans phenothrin* (CAS No 26046-85-5, EC No 247-431-2), concentration **2,247%**;

LEGMC assigns the authorisation number for biocidal product non flammable aircraft insecticide phenothrin:

LV/2021/MR/018

The authorisation is valid until 26 March 2029.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **non flammable aircraft insecticide phenothrin** through mutual recognition is granted on the following terms:

- Product type: 18 Insecticides;
- Target organisms: Mosquitos adults *Culex spp*; Mosquitoes adults *Aedes spp*; Mosquitoes adults *Anopheles spp*; House fly adults *Musca domestica*.
- Users: professional;



- Product description: ready to use aerosol dispenser for use in aircraft;
- Product stability: shelf life 24 months;
- Use area: indoor areas;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product **non flammable** aircraft insecticide phenothrin in the composition, form and packing for which the authorisation for **non flammable** aircraft insecticide phenothrin is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **non flammable aircraft insecticide phenothrin** should be as it is indicated in the authorisation of above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Produits Sanitaires Aéronefs shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **non flammable aircraft insecticide phenothrin** through mutual recognition may be re-opened for review before 26 March 2029.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally, LEGMC would like to inform that Produits Sanitaires Aéronefs is fully responsible of the content of the biocidal product **non flammable aircraft insecticide phenothrin** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Produits Sanitaires Aéronefs to notify the above-mentioned information down to supply chain.
