On major changes of the simplified authorisation of the biocidal product family LACTIVO 150 BPF

Latvian Environment, Geology and Meteorology Centre (LEGMC) received an application submitted by **Specialities S.r.l.** on 21 April 2023 for major changes via Register for Biocidal product (Case No. BC-QJ085908-11) in accordance with Article 8 of *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council* for the biocidal product family **LACTIVO 150 BPF** with authorisation number **EU-0027768-0000**.

LACTIVO 150 BPF is authorized by LEGMC on 2nd August 2022 under the simplified procedure in accordance with Articles 25 and 26 of the *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (regulation (EU) 528/2012).

LEGMC has agreed with the following proposed major change:

- Merge of “Use 2.1: Multi surfaces disinfection (professional and non-professional). PT2-4. Target organisms: bacteria and yeasts.” and “Use 2.2: General surfaces disinfection (professional). PT2. Target organisms: bacteria, yeasts and enveloped virus.” under Meta-SPC 2 into the one use: “Use 2.1: Multi surfaces disinfection (professional and non-professional). PT2-4. Target organisms: bacteria, yeasts and enveloped viruses.”

Due to the proposed major changes the following trade names became not relevant and were excluded from the authorisation: LACTIVO 150 General Surfaces (pro), LACTIVO 150 CI 02 General Surfaces (pro), LACTIVO 150 CO 02 General Surfaces (pro), LACTIVO 150 ML 02 General Surfaces (pro), LACTIVO 150 LT 02 General Surfaces (pro), LACTIVO 150 FEE 02 General Surfaces (pro), LACTIVO 150 CI General Surfaces (pro), LACTIVO 150 CO General Surfaces (pro), LACTIVO 150 ML General Surfaces (pro), LACTIVO 150 LT General Surfaces (pro), LACTIVO 150 FEE General Surfaces (pro).

Sufficient evidence was provided that the proposed major changes do not affect the LACTIVO 150 BPF physical and chemical properties, classification and efficacy. No changes with regard to the condition of use. Therefore, LEGMC concluded that the existing authorisation can be maintained.

LEGMC has developed Product Assessment Report and Summary of Product Characteristics for LACTIVO 150 BPF based on the proposed changes.

This letter is integral part of the authorisation of the biocidal product family LACTIVO 150 BPF (authorisation letter No. 4-6/991 issued on 2th of August 2022).
