On an authorisation of BRODY FRESH BAIT through mutual recognition

Latvian Environment, Geology and Meteorology Centre (LEGMC) is the Competent Authority for implementation of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*. On 8th August 2012 LEGMC received the application for the authorisation of **BRODY FRESH BAIT** through mutual recognition in parallel submitted by Kollant S.r.l.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **BRODY FRESH BAIT** developed by the reference Member State – Italy.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products LEGMC authorise the **BRODY FRESH BAIT** on the basis of mutual recognition process.

The authorisation holder for **BRODY FRESH BAIT** in Latvia is:

Kollant S.r.l.

BRODY FRESH BAIT contains 0.005 % (w/w) of *brodifacoum* (CAS No. 56073-10-0, EC No.259-980-5) as active substance.

LEGMC assigns the authorisation number of BRODY FRESH BAIT through mutual recognition:

LV/2018/MR/002

The authorisation of BRODY FRESH BAIT through mutual recognition is valid until 30th August 2020 based on reference Member State – Italy decision.

The authorisation number of **BRODY FRESH BAIT** through mutual recognition shall be indicated on the label of the biocidal product.

The authorisation of **BRODY FRESH BAIT** through mutual recognition is granted on the following terms:

- Product type: it is only authorised for use as a product type 14 – Rodenticides: brown rats and house mice
- Users: professional;
- Product description: is a ready-to-use fresh paste bait furnished in sealed food paper bags;
- Product stability: shelf life 2 years;
- Use area: in and around industrial, commercial and residential buildings, in open areas and waste dumps;
- Packaging size: packaging sizes and materials are: PET bags containing 1-25 kg.

The authorisation through mutual recognition applies only to the biocidal product **BRODY FRESH BAIT** in the composition, form and packing material for which the first authorisation is granted by reference Member State to **BRODY FRESH BAIT**.

The information on the label (and if applicable an enclosed instruction of use) of the **BRODY FRESH BAIT** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

Kollant S.r.l. as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council*.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **BRODY FRESH BAIT** through mutual recognition may be re-opened for review before the 30th August 2020.

Additionally LEGMC would like to inform that Kollant S.r.l. is fully responsible of the content of the biocidal product **BRODY FRESH BAIT** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Kollant S.r.l. to notify the above mentioned information down to supply chain.
