## Background

An application for a minor change was received concerning the packaging size of Mosquito Milk Spray 30% DEET and Mosquito Milk Spray 50% DEET. The minor change was also applied for in Belgium and Luxembourg (see table below).

## Packaging of the biocidal product

Changes to the packaging sizes were applied for:

### Mosquito Milk Spray 30% DEET

The packaging is changed to include 15-250 mL HDPE bottles as well as 15-250 mL PP bottles, in addition to the existing authorization of 75 mL PP bottles. Both the authorized bottles and the bottles applied for are equipped with a spray pump/dispenser.

### Mosquito Milk Spray 50% DEET (Jaico Muggenmelk Spray 50%)

The packaging is changed to include 15-250 mL HDPE bottles as well as 15-250 mL PP bottles, in addition to the existing authorization of 75 mL PP bottles. Both the authorized bottles and the bottles applied for are equipped with a spray pump/dispenser.

## Decision

### Mosquito Milk Spray 30% DEET

The new packaging can be authorized based on extrapolation of the existing PP bottles evaluated for the authorization of the Mosquito Milk products and the addendum to the PAR (March 2015).

Packaging authorized: 15 – 250mL HDPE or PP bottles, equipped with spray pump/dispenser.

**Mosquito Milk Spray 50% DEET (Jaico Muggenmelk Spray 50%)**

The new packaging can be authorized based on extrapolation of the existing PP bottles evaluated for the authorization of the Mosquito Milk products and the addendum to the PAR (March 2015).

Packaging authorized: 15 – 250mL HDPE or PP bottles, equipped with spray pump/dispenser.
