On an authorisation of biocidal product Wolmanit CX-10_family through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by Wolman Wood and Fire Protection GmbH on 21st August 2015 concerning an authorisation of **Wolmanit CX-10_family** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **Wolmanit CX-10_family** developed by the reference Member State – Austria.

LEGMC takes into account that the conditions of Article 19 (1-4) and (6) of *Regulation* (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (regulation 528/2012) are only fulfilled for use of the products for treatment of wood which is intended for use in class 1 and 2.

Therefore, in accordance with Article 34 of the regulation 528/2012 LEGMC authorises **Wolmanit CX-10_family** on the basis of mutual recognition process only for use in use class 1 and 2.

Wolmanit CX-10_family contains the following active substances:

LEGMC assigns the authorisation number LV/2024/MR/003 for Wolmanit CX-10_family.



In accordance with Article 22 (2)(d) of the regulation 528/2012 authorisation numbers with the following suffix for biocidal products within family are indicated in the following table:

The authorisation is valid until 6th October 2028.

The authorisation numbers shall be indicated on the labels of the biocidal products.

The authorisation is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organism: wood destroying fungi, wood boring beetles and termites (subterranean termites);
- Users: industrial;
- Application methods: vacuum pressure treatment / oscillating pressure process, indoor; UC 1-2;
- Product description: soluble concentrates;
- Product stability: 24 months.

The authorisation through mutual recognition applies only to **Wolmanit CX-10_family** in the composition, form and packing material for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of **Wolmanit CX-10_family** should be as it is indicated in the first authorisation, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of regulation 528/2012,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.
