On an authorisation of the biocidal product TEKNOL AQUA 1411-011

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Teknos A/S** on 14 September 2018 concerning an authorisation of **TEKNOL AQUA 1411-011** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **TEKNOL AQUA 1411-011** developed by the reference Member States – Denmark.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises the **TEKNOL AQUA 1411-011** on the basis of mutual recognition process.

The authorisation holder for TEKNOL AQUA 1411-011 in Latvia is:

Additional trade name for **TEKNOL AQUA 1411-011**:

TEKNOL AQUA 1411-01.

The biocidal product **TEKNOL AQUA 1411-011** contains following active substances:

- *3-iodo-2-propynylbutylcarbamate (IPBC)* (CAS No 55406-53-6, EC No 259-627-5), concentration **0,3%**;
- 1-[[2-(2,4-dichlorophenyl)-4-propyl-1,3-dioxolan-2-yl]methyl]-1H-1,2,4-triazole (propiconazole) (CAS No 60207-90-1, EC No 262-104-4), concentration 0,6%;

LEGMC assigns the authorisation number for TEKNOL AQUA 1411-011:

LV/2022/MR/002

The authorisation is valid until 9 February 2026.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **TEKNOL AQUA 1411-011** through mutual recognition is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organisms: Blue stain fungi hyphae *Ascomycetes, Deuteromycetes*, Brown rot fungi hyphae *Basidiomycetes*; White rot fungi hyphae *Basidiomycetes*;
- Users: professional, trained professional, industrial;



- Product description: ready to use;
- Product stability: shelf life 24 months;
- Use area: indoor areas;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product **TEKNOL AQUA 1411-011** in the composition, form and packing for which the authorisation is granted by reference Member State to **TEKNOL AQUA 1411-01**.

The information on the label (and if applicable an enclosed instruction of use) of the **TEKNOL AQUA 1411-011** should be as it is indicated in the authorisation of above-mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- *Article 69 Regulation (EU) No 528/2012*;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16
 December 2008 on classification, labelling and packaging of the substances and mixtures,
 amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation
 (EC) No 1907/2006;
- all other relevant legislation shall be applied.

Teknos A/S shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **TEKNOL AQUA 1411-011** through mutual recognition may be re-opened for review before 9 February 2026.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally, LEGMC would like to inform that Teknos A/S is fully responsible of the content of the biocidal product **TEKNOL AQUA 1411-011** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Teknos A/S to notify the above-mentioned information down to supply chain.
