Amendment of the Icelandic authorisation for the Union authorised biocidal product family, INSECTICIDES FOR HOME USE

Regulation (EU) No 528/2012 concerning the making available on the market and use of biocidal products and Commission Implementing Regulation (EU) No 354/2013 (on changes), are implemented into Icelandic legislation through Icelandic Regulation No 878/2014 on biocidal products.

The biocidal product family INSECTICIDES FOR HOME USE is authorised in Iceland with an implementing decision in EEA countries and Switzerland (EE-APP), with reference to the Union Authorisation – EU-0021035-0000.

The Environment Agency of Iceland (Umhverfisstofnun) received an application for amendment of the implemented decision on 26 April 2022, Case No BC-BY075173-17. The amendment concerns addition of the following trade names to the biocidal product family, as referred to in Section 1 of Title 1 of Annex to Commission Implementing Regulation (EU) No 354/2013 (on changes):
