# Acceptance of administrative changes for Koppers Performance Chemicals Denmark ApS – Protim P-Vac 11 – NO-2014-0043

We refer to the notification dated 20 January 2023 for administrative changes to the national authorisation of the biocidal product Protim P-Vac 11, R4BP 3 case number BC-LV083977-89.

### Decision

The Norwegian Environment Agency hereby accepts the notified administrative changes to the product authorisation for Protim P-Vac 11 on the Norwegian market.

### Terms and conditions for the change to the authorisation

The revised terms and conditions are described in the final Norwegian Summary Product Characteristic (SPC) attached to the R4BP3 asset case no. NO-0005014-0000. The terms and conditions as stated in the authorisation letter dated 20 February 2014 also apply.

The approval is given in accordance with Article 6(4) of Regulation (EU) No 354/2013, c.f. Article 50 of Regulation (EU) No 528/2012 (the Biocidal Products Regulation, BPR).



# Background

Regulation (EU) No. 528/2012 and Regulation (EU) No. 354/2013 are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No. 480.

The procedure for applications for administrative notifications to authorisations are set out in Article 6 of Regulation (EU) No 354/2013.

#### The notification concerns

Koppers Performance Chemicals Denmark ApS has notified administrative changes to the authorisation of Protim P-Vac 11 on the Norwegian market. The notified changes concern a transfer of the national authorisation as referred to in Section 1 of Title 1 to the Annex to Regulation (EU) No 354/2013 and a change of the manufacturer's address as referred to in Section 2 of Title 1 to the Annex to Regulation (EU) No 354/2013.
